I rejoice that the day has dawned, in which the North and South will think, and feel, and act together on the subject of slavery. I thank that for the agitation. We might add, with that illustrious author, that in every country, however severe the toil which society exacts, the results may be obtained from freemen, by encouraging them with rewards and privileges, adapting the labor to their strength, by bringing to their aid machinery which art invents, and which, we may add, art has invented abundantly since the days of that great invented abundantly since the days of that great writer. But we prefer waiving such material considerations, and dwelling upon our argument in a Christian point of view. We acknowledge, dear brethren, that slavery is not explicitly abolished in the New Testament; we see that Christian masters are not prohibited from having slaves, (Cel. iv. 1; Eph. vi. 9,) and that slaves are exhorted to submission and fidelity, (Eph. vi. 5, 8; Col. iii. 22, 25; Titus iii. 9, 10; 1 Peter, ii. 5, 18.) Is He not the true and living God. of the black as well as the white man? If the Eternal Son, who is God forever and ever, became man, was it not for the Greek as well as the Jew, for the slave as well as the free? Does not the righteousness which was acquired on the cross by the atonin blood of the Lamb, cover the sins of the one as we as of the other? Does the Holy Spirit, which changes the hearts of all in whom he dwells into the temples of the Holy Ghost, make any distinction of color? Ought we not to exclaim now with the primitive Christians, 'By one spirit are we all baptized into one body, whether we be bond or free'? (1. Cor. xii. 13.) 'There is neither bond nor free, but Christ is all and in all.' (Col. iii. 11.) Such but Christ is all and in all.' (Col. iii. 11.) Such being the teaching of the Scriptures, do you not think with us, beloved brethren, that these principles suppress the spirit of slavery, and only leave its name and appearance? Do you not believe that since God, our common Father, bestows the tender sympathies of his love equally upon the slave and the free, we their brethren cannot refuse the precious boon of liberty to those who are deprived of it? If Christ has made them free shall not see free it? If Christ has made them free, shall not we fre them also? Christianity in general did not lay vio-lent or imprudent hands on civil institutions, but spread its principles everywhere, and gave precepts to all men, the application of which was

to bring about the suppression of all abuses.

These considerations are important; but, we repeat, what particularly induces us to make an appeal to your consciences is the system of laws, manifestly opposed to the sprit of Christianity, with which several of your States have been obliged to burden their legislation, in order to maintain slavery in the midst of you. It is not needful to enumerate these laws; we know them from official documents published in Europe, and which caused both aston-ishment and grief to the friends of religion, morality and liberty. We are aware these laws do not exist in a good many of your States; we know that, exist in a good many of your States; we know that, with the exception of one or two laws, legislation on slavery is local, instituted in their sovereign power by those States alone which practise slavery. But that in no way prevents us from freely expressing the sentiments which animate us, either to just and moderate men, who doubtless are to be found in abundance in the Southern States, or to all the

Christians of the American Union.

If we mistake not, there are three classes of opinions and of persons in the United States, as to the ions and of persons in the United States, as to the present subject; one is decidedly against slavery, the other is decidedly in its favor; but there is a medium class which hesitates, and we think the moment has arrived when all those who belong to that class ought to decide before God and their conscience, wisely, but with courage and firmness. Between Christianity on one side, and utilitarianism on the other, we do not think that Christians should

The two great features which characterize the United States, and which form the essence of your people—are they not, honored friends, the Gospel and Liberty? And are you not called upon both to enjoy these two blessings for youselves, and to testify to others how happy are those nations who possess them, and thus to be the means of spreading them in the world? Now, it is precisely the Gospel and Liberty which are implicated in this question. The maintenance of slavery might hinder the growth of these two great principles. How often have we been tempted to exclaim, 'Tell it not in Gath, publish it not in the streets of Askelon, lest the daughters of the Philistines rejoice.' (2 Sam. 1:20.)

Dear brethren, listen to these voices, which come from a far-distant land at the foot of the Alps, from the town of the Reformation, and are raised in concert with those in France and other countries. We would entreat you by the most precious interests; in the name of the prosperity of the Union, of the peace, of the glory of your country; in the name of the cause of true liberty; and, above all, of the holy and great cause of Christianity, to do all in your power, with an unflinching fidelity, to bring about the suppression of slavery and the establishment of social liberty in your country. Let it be done with wisdom, with kindness, with justice, without disturbing the public peace, but, notwithstanding, as promptly and as universally as possible.

The Church and Slavery. By ALBERT BARNES. The spirit in which this book is written com justifies the respect so universally entertained for its author. We cannot refrain, however, from expressing entire dissatisfaction with its results;—we should deprecate their being made the basis of action at the next meeting of the Assembly at Cleve-

land.
1. Mr. Barnes represents the position of the N. S. Presbyterian Church as one of firm and unbroken hostility to the system of slavery as 'inconsistent with the law of God.' Now, in two very vitai particulars, this representation is exaggerated, and cal-culated to mislead. First, The action of the General Assembly has always been greatly divided on this question, So far from bearing the character of united condemnation, in the last three or four years, whatever resolutions have been passed testifying against slavery, have been passed, as is well known only against the largest and most determined oppo sition. Those who were present at Buffalo, at St. Louis and at New York, will remember that the ac-tion in those assemblies was the result of long and doubtful contest, and even then was secured only by a small majority. Nor should we forget, that the opposition in these cases was not by any means exclusively from the South, nor from the less prominent mambers of the body. On the contrary, it was from some of the leading pastors of the Church, whose names, notwithstanding the vote of a small majority, would exert a wide and powerful influence. influence. Secondly. Mr. Barnes omits all mention of that powerful retrogression going on in the Church, respecting the moral character entertained Such a fact should by no means be excluded from an estimate of the position of the Church, for a church organization without respon-sibility for the doctrinal defection of its parts is the greatest of absurdities. But in this omitted fact is found, more than in anything else, a mighty element of influence in behalf of slavery. What matters it if we can find, on the Assembly's minutes, resolutions ever so stringent against slavery, if it has become the settled doctrine of multitudes of its churches, that American slavery is justified by the Bible? Such a fact as this latter renders the strength of the Church's testimony in behalf of freedom worse than weakness.

2. The impression of Mr. Barnes's book is, tha little is left for the Church to do. The consid erations just adduced lead us to protest against such a position. We need something more than divided resolutions on our minutes. An open and contin resolutions on our minutes. All open at until the und discussion of this subject is demanded, until the truth shall completely prevail, and the Church, through its Assembly, shall give unbroken testimony against the sin in question. We have great confidence in truth, that it will extend like leaven; therefore, we hope and pray for its discussion. But there is another kind of action needed, and it is in respect to this that the Church has been specially and very greatly untrue to her responsibilities. Res-olutions are good in their place; but before the Presbyterian Church can meet her responsibilitie

fully, she must follow up her resolutions by corres fully, she must follow up her resolutions by corresponding action. The testimony she has given against sin has not been heeded—has been treated with a marked contempt; slavery, in forms outrageously sinful, exists unnoticed in her churches. This culpable neglect of discipline is sought to be justified by the Bible; and a gigantic doctrinal apostacy has become established with vigorous growth in the very heart of the Church. As a consequence, the Church is now practically even a moral bulwark of slavery.

HEMARKS OF WM. LLOYD GARRISON,

Mr. Garrison began by saying that he accept kindly extended to him, in behalf of the meritoriou Society holding its meetings in that hall to speak t the people in advocacy of the world-elevating doctrine of total abstinence. But, after a discussion protracted Joseph Ford, a Buchanan democrat of Minnesota, publishes a letter in the Chicago Tribune, detailing a conversation which he held, a few days since, with ex-Gov. Geary on Kansas affairs. The following extract will be read with interest: I repeat his language as literally as possible, and novelty in the further elucidation of this subject. Thirty years ago, then a young man just entering his majority, he had taken the pledge, and consistently adhered to it to the present time. Soon afterward he became the editor of the first temperance journal ever established in the world, entitled the 'NATION' AL PHILANTHROPIST,' and bearing this motto:-Moderate drinking is the downhill road to intempe rance and drunkenness'-a journal established not b himself, but by his predecessor, the late venerable WILLIAM COLLIER, a Baptist clergyman of this city who deserved to be held in lasting remembrance for his zeal, perseverance, moral courage, and self-denying philanthropy. If he (Mr. G.) had since that time given less of direct effort to the temperance cause than formerly, it was not because he had lost any of his interest in its success, but because it had fought its way through to respectability, and because he had had his sympathies early awakened and his energies constantly tasked in behalf of the enslaved millions in our land, for whose deliverance there appeared so few to plead, in an uncompromising spirit, even at this late day.

Mr. G. proceeded to speak of the cheering contrast which was seen between the condition of this beneficent enterprise in 1827 and in 1857. Then, there was scarcely a pledged tectotaller to be found; now they are to be counted by millions. Then, the position of the pulpit (with very rare exceptions) was in direct hostility to the doctrine of total abstinence as a fanatical innovation, in conflict with the teachings of 'the inspired word,' and an impeachment of the character of Jesus, who wrought a miracle that he might turn water into wine; now, the pulpit had generally ceased its opposition, and to a wide extent gave the cause its countenance and support. Then, the churches were lax in discipline, and greatly infected by inebriety; now, they were characterized by a general acceptance of the temperance movement, and in many instances bore a decisive testimony in its favor. Then, there was but a single temperance journal in all the land ; now, they were multitudinous, in addition to a friendly co-operation on the part of the religious and secular press. Then, the movement was universally ridiculed; now, its odiousness had ceased, and its most earnest advocacy excited no reproach or persecution. Then, it reached only the individual conscience; now it had taken political mastery of several of the American States, and stamped itself on the Statute

For instance :- Since it is well known that planters do not suffer the reproductive powers of their claves to lie idle, but bestow even more personal attention upon the increase of this than of any other variety of their cattle, it is very possible that there may be now in existence the fifth generation in regular (or rather irregular, but certainly natural,) descent from the daughter of Thomas Jefferson, formerly President of the United States. Now if we make the supposition, not at all improbable, that a daughter was born in each stage of this descent, and the further supposition, a highly probable one, that each of tiese successive daughters had issue by her master, or his son, or the class-mate or other young Northern friend to whom this son was showing 'hospitality, we shall have, in the child last born, merely one sixtr-fourth, or one hundred and twenty-eighth part of African blood; the former, if the ex-President's fawrite were black, the latter, if she were vellow. But the singular fact is, that this minute proportion of black blood not only annihilates the sixty-three sixty-fourths, or the hundred and twenty-seven hundred and twenty-eighths of white blood, making its possesor fully and absolutely what Mr. Stephens calls negro, and his overseer a nigger, but it annihilates also the ordinary rules of nativity, stamping as an African and an Ethiopian, (both of which terms Mr. Stephens uses interchangeably with 'negro,') a person who was not only born in the United States, but whose ancestors, for five generations back, have all been born at some point between Virginia and Still further: Not only does this minute interfusion

of black blood reverse the technical designation of the white blood so, profusely mingled with it, which would otherwise have remained Caucasian-Virginian. or Anglo-Saxon-Georgian, it annihilates the intellectal superiority which is in other cases transmitted from sire to son, and leaves the unfortunate possesson s 'nigger' in his possibilities not less than in his actal state. So that the last branch of the genealogital tree we have been describing is not merely one saty-fourth or one hundred and twenty-eighth part less admirably organized than the thorough-bred, Simon pure Virginian or Georgian, it is not well orgapixel at all; it cannot take care of itself, and so must have an overseer, though, strange to say, it enarseer to get his food and ra sort of industry not, in other cases, esteemed productive, the flourishing of a cowhide; it cannot earn its can living, and so needs a master, though, wonderfal to tell, with that master, it can earn the living of both, and leave a large balance for billiards and racehorses, Newport and Saratoga; it cannot improve by instruction; this was thoroughly proved by a humane, though Quixotic experiment of Mrs. Margaret Dougles, of Virginia, who has candidly published an accounts of the utter failure of her efforts, admitting that she succeeded in communicating, even the first radiments of knowledge, to but very few, and that even these soon forgot what they had learned. The claim made, on very doubtful authority, of some few exceptional cases, in which beings of this description, after outrunning hounds and hunters, dodging rifleballs, and evading kidnappers and commissioners, have, under the influence of a different diet and regimen, outgrown their incompetency, and made speeche, written auto-biographies, delivered lectures and elited newspapers, cannot for a moment be admitted to weaken the immense mass of evidence existing under the general rule, and thus Mr. Stephens's argument stands firom and impregnable as hypothesis it-

But it is said that Massachusetts has no right to make such a law.

Let us examine the precedents. The constitution declares certain offices incompatible. Such offices can not be made compatible by any act of the legislature ; but it by no means follows that the legislature cannot add to the list of incompatible offices.

Has the legislature ever added to the number of incompatible offices?

On March 3, 1810, the legislature passed a law rendering certain offices incompatible, as follows 'No person who holds the office of attorney-general, district-attorney, justice of the court of common pleas, ers under the law of 1793; or, in other words, they clerk of the same court, or sheriff, shall hold the office could make the office of Judge of Probate incomps of county treasurer.'

Now, if the law of 1810 was constitutional, then most certainly the law of 1855 must be consitutional also, so far at least as it affects the incompatibility of the office of Judge of Probate incompatible with the

Your Committee ask particular attention to the facts in regard to this law. This law remained unquestioned upon the statute book for about twentyfive years. But this is not all. When the statutes of Massachusetts were to be revised, the Hon. Charles Jackson, the Hon. Asahel Stearns and John H. Ashmun, Esq., were appointed to make this revision, and on the death of Mr. Ashmun, the Hon. John Pickering was appointed in his stead, men holding the very first rank in the legal profession. Now had this law been unconstitutional, is it probable it would have passed unscathed through the hands of these commissioners? Yet it did pass through, and is still retained in the body of the Revised Statutes.

Then there is another significant fact bearing upon the point now under consideration. In the convention of 1820, the resolution, which provides that judges of courts and United States officers shall not hold certain offices, being under consideration, the Hon. Elijah Alvord, of Greenfield, a man of the highest integrity and moral worth, and of great influence in the convention, moved, on December 25th, to amend, by adding after the provision that judges of courts of common pleas shall hold no other office, except of justice of the peace and military offices- provided, prive any such judge of any office which he now lawfully holds."

Mr. Webster scouted the idea of making a difference between those now holding office and those who might hereafter be appointed to office, and thought that if the amendment should operate immediately upon any officer included in it, it ought to operate on all. He was against the amendment.

Mr. Alvord said it was a different question, whether could not reconcile it with his notions of justice, that persons who had accepted offices under the constitution should be deprived of them by the creation of an incompatibility by an alteration of the constitution.

Messrs. Lawrence, of Grotone Lincoln, of Worcester, Willard, of Fitchburg, and Walker, of Templeton, spoke against the amendment. The amendment wa negatived. [Massachusetts convention of 1820, page

Thus then, the policy of the State, as to the application of incompatibility of offices, was established beyond a doubt, to wit, that incompatibility may operate equally upon all,-upon the person in actual possession, as well as upon the person appointed to office subsequently to the passage of the Act rendering the offices incompatible.

This action, too, was taken in the very face of a protest put in, as an amendment, by a distinguished member of the convention, asking the convention to except those judges who already lawfully held offices, now about to be rendered incompatible. The convenon, after debate and deliberate consideration, refused to make any exception in favor of the judges.

Thus the antiquated doctrine of vested rights in an office was repudiated in Massachusetts. In fact, it never got a footing in Massachusetts, inasmuch as the constitution itself, part 1, article 4, expressly says, · the idea of a man being born a magistrate, lawgiver, or indee, is absurd and unnatural !

Again, (article 5,) all officers of government, whether legislative, executive or judicial, are at all times accountable to them,' viz., to the people.

On March 12, 1784, the legislature enacted a law prohibiting any sheriff from appearing as counsel or attorney in any court of this Commonwealth.

In 1855, every court established by the laws of this Commonwealth was prohibited from any jurisdiction whatever in respect to naturalization of aliens under the laws of the United States. That is, the function of naturalizing foreigners was deemed incompatible with the office of Massachusetts judge.

In 1856, the compatibility of these two functions was restored to the higher courts.

Then again, the Act of 1843, commonly called the Latimer law, forbid Massachusetts magistrates to act under the law of 1793, in respect to 'fugitives from service and labor.' Yet by this Act, jurisdiction in all cases of the extradition of fugitives from service or labor was vested 'in any magistrate of a county, city or town corporate, and, therefore, as Judge Loring justly says, in his Protest of February 9, 1855, in any THE DRED SCOTT DECISION AT CHICAGO. person holding a commission of justice of the peace.

Now all these magistrates became United States officers the moment they acted under the Act of 1793 Because the Supreme Court has decided that exercising powers conferred by Congress, is holding office under the United States. [Jackson v. Row, National Intelligencer, Dec. 23, 1815.]

Then, on the ground assumed by Mr. Loring, ir his Protest of March 9, 1857, could these magistrates be forbidden constitutionally to act under the law of 1793? They were forbidden so to act by the law of tained :-1848, and that law has never been declared unconstitutional.

If the undersigned had any doubt that Massachusetts had the constitutional right to render the holding of the office of Judge of Probate, or any other State office, incompatible with the holding of an office under the United States, the decision of the Supreme Court in the Prigg case would dissipate that doubt.

It does not help the matter for Mr. Loring to say the United States Slave Commissioner is one officer, and the Judge of Probate is another officer, and that when I act as Judge of Probate, I am no longer Slave Commissioner; and when I act as Slave Commission er, I do not do it by virtue of the commission that I hold as Judge of Probate; whereas the magistrates who acted under the law of 1793, acted in virtue of the commission they held as State magistrates.

This, at first blush, seems plausible, yet, on examination, it will be found to be a distinction without a difference.

Resides, this is not the material point. Com sioner Loring and Judge of Probate Loring are, after all, one and the same man, and it matters not with Massachusetts whether Mr. Loring makes a man a slave by virtue of his commission as United States Commissioner, or by some additional function conferslave by virtue of his commission as United States of persons only, not property nor can the warden of any prison hold such property in custody. The Court say: 'As to the authority so conferred upon State magistrates, while a difference of opinion has existed, and may still exist, on this point, in different States, whether State magistrates are bound to act under it, none is entertained by this Court that State magistrates may, if they choose, exercise the authority, unless prohibited by State legislation.' That is, State Legislatures could prohibit State magistrates from acting as slave-catchible with the slave-catching function.

Then, does it not follow, as a just deduction from this decision, that the State Legislatures may make office of Slave Commissioner under the Bill of Sept. 18, 1850, especially as the Bill of 1850 is entitled, and is, 'An Act to amend, and supplementary to the Act' of 1793 }

Views similar to those held in Massachusetts, in re spect to the unconstitutionality of making offices in compatible, are entertained by other States in this Union. Take Virginia, for instance.

'No person shall be capable of holding any such post, to wit: State office, who holds any post profit, trust or emolument, civil or military, legislative, executive or judicial, under the government o the United States, or who receives in any way, from the United States, any emolument whatever.'

torney to summon such witnesses as he shall deem necessary to substantiate such defence, whose fees and all other necessary and leaves the such defence. all other necessary and legal expense incurred in maling such defence shall be paid by the State. SEC. 3. This act shall take effect from and after it approval by the Governor. [Approved April 14, 1857.

An Act declaring all slaves brought by their mas ters into this State free, and to punish any attemp to exercise any authority over them.

Be it enacted by the Senate and House of Represente

Section 1. Any slave voluntarily brought into this State by his master, or with his knowledge or consent shall thereby become free; and if restrained of hi liberty, he may, on the writ of habeas corpus, be disliberty, he may, on the writ of habeas corpus, be dis-charged from such restraint; and any attempt by any person to restrain such slave of his liberty, or to exer-cise the authority of master over him, shall be pun-ished by a fine not exceeding one thousand dollars, or by imprisonment not exceeding one year.

approval by the Governor. [Approved April 15, 1857.]

THE PENNSYLVANIA LEGISLATURE-CASE OF DREI Scorr.—The majority of the Select Committee of the Senate, on the resolutions in the Dred Scott case, have made a lengthy report, accompanied with resolutions, declaring that the opinion of the Supreme Court andeclaring that the opinion of the Supreme Court announces principles in palpable opposition to the judicial and legislative history of the Union, and in violation of the plain provisions of the Constitution of the United States; that the opinion, except on the question of jurisdiction, being delivered on a case over which the court admitted it had not jurisdiction, may be justly regarded as obiter dicta coram non judicie, and inoperative as law; that the five judges who concurred in the same opinion made a wanton attack on the sovereignty of the free States, and an impotent attem, to nullify the established laws of this country, and by extra judicial action caused an unnecessary and by extra judicial action caused an unnecessar excitement to the public in regard to the subject of slavery, and thereby forfeited the confidence and respect due to their exalted station.

#### CAPTURE OF AN AMERICAN SLAVER.

The Kingston (Jamaica) Journal of April 23d. received by the Illinois, contains the following :

On Thursday last, the 16th instant, the inhabitant of St. Ann's Bay were thrown into a state of considerable excitement by the arrival of a schooner—evidently American—towed into port by H. M. brig 'Arab.' It was soon ascertained that the schocner was a slaver, and that she had on board a large numwas a slaver, and that she had on board a large num-ber of captives. It appears that the captain of the 'Arab' had received information, that a bark and schooner were expected in Cuba from the Coast of Africa, each with a cargo of slaves; a strict watch was therefore kept, and on Monday the 13th instant, a suspicious-looking craft was seen with a full press of sail, making the best of her way to her destined port. She was closely pursued, and the captain finding that there was no possibility of escaping from the 'Arab, deserted her, taking with him in a shallop, his crew money, chronomoter, and other useful articles. The Commander of the 'Arab' despatched his gunboat with 15 men, under the command of his first lieutenant, with orders for the capture of the shallop,—the chase continued for nearly three hours—and a shot having destroyed the rudder of the shallop, the captain, who was owner of the slaver, surrendered. Two of his principal slaves and an interestication. principal slaves, and an interpreter, were taken from the shallop, and the crew left in it, to make the best the shallop, and the crew left in it, to make the oest of their way to Cuba. The first lieutenant then boarded the schooner, and found her filled with young Africans, males and females, to the number of 373, no less than 127 having fallen victims to the horrors of the middle passage, during a voyage of 29 days. The poor captives were in a wretched condition—all of them were naked—and the greater part seemed to have been half starved. They were packed closely together, and covered with dirt and vermin. The caption of the caption tain of the schooner refused to give his name or the name of the vessel, but stated that he would be a loser of \$30,000—a loss which did not cause him much con of \$30,000—a loss which did not cause him much con-cern, as he had made other and successful trips. A great deal of information, however, has been obtained from the interpreter, who mentioned that several vessels were left on the African coast—that they were to have sailed soon, with full cargoes—that upon an average, two vessels departed weekly, each with 500 to 700 slaves on board—that the trade was rapidly in-creasing—and that the slaves, on being landed in Cuba, were worth from \$500 to \$700 each. The 373 liberated slaves will, of course, be apportioned in lots to the proprietors whose applications are in the office of the Lieutenant Governor.

Resistance to Law in Mississippi.-The Holly Springs Democrat contains the proceedings of a public meeting held at Byhalia, Miss., for the purpose of resisting the enforcement of certain acts passed at the last Legislature, prohibiting the circulation of bank bills under the denomination of five dollars, and the punishment of slaves with more than thirty-nine lashpunishment of slaves with more than thirty-hine tashes for any one offence. They denounced the first as 'inconvenient, unnecessary and intolerable,' and the second as 'abusive of power, insulting and injurious to the South.' They also resolved to disregard both of the laws, and to resist by force any attempt to punish the responsibility of what their violation, 'throwing the responsibility of what may follow resistance upon the Legislature, who are

More than one hundred of the prominent mem bers of the "Young Men's Christian Association" in New York have withdrawn from that organization, because a majority of its members voted to discuss the subject of slavery. Among the seceders are Rev. Drs. Spring, DeWitt, Potts, Alexander, &c., who ac cuse the association of departing from the object originally contemplated, which was the consideration o purely evangelical subjects, and not the discussion of political and reformatory questions. Young America, under the lead of such men as Henry Ward Beecher and George B. Cheever, in the Independent, has carand George B. Cheever, in the Independent, has carried the day; while old-fashioned conservative Orthodoxy, in the New York Observer, has been compelled to secede. Rumor says that the seceders will form another association. Meanwhile, the "Young Men's Christian Union," in New York, composed of members in sympathy with the liberal churches in that city, is open for the discussion of both sides of all great moral and reformatory subjects, and lately listened to a long and claborate defence of slavery.—

There are those who, from their stand-point of experience and observation, contend that the colored people excel the whites in these religious manifestations; and in support of the position that they are thus more emotional, they quote largely from books of science and philosophy. Others, again, deduce from these same premises a conclusion not so favorable; but as it is not our present purpose to exercise the function of a polemic, we are content to claim for the colored brethren and sisters equality with the whites in

This was not the first of the kind, nor will it be the last.

On the evening of the same day, a parlor dramatic representation was the nucleus around which was gathered a select and highly gratified company. Had there been any of the satellites of Judge Taney present, with their prejudices that should be conquered, they could have gleaned evidences abundant of the equality of colored with white; for among the dramatis persona and their guests were to be seen representatives of the arts and professions in rather more than ordinary proportion. One lawyer, who has been admitted to practice in the United States Circuit Court, Judge Sprague on the bench, who must of course have had good evidence of his color; (who shall decide when judges disagree as to the citizenship of colored Americans?) one physician, a member of the Massachusetts Medical Society, whose collegiate acquirements in America were improved by transatlantic discipline, and whose perseverance and patience under discouraging obstacles deserve a long list of patients to be relieved by his gifts of healing; one portrait painter, whose productions in oil and crayon have already been rewarded with general approbation; (the walls of this temporary Thespian temple were adorned with several landscape compositions by another young artist;) a daguerrian operator, an ornamental gilder-both very successful-together with clerks, printers, &c. &c., were conspicuous personages in this

There are also clubs and circles for the special cultivation of music, reading, and other branches. A letter from a member of one of their book clubs state that they have for their object 'the improvement of the mind, and therefore only solid and instructive

It was our good fortune to be present on a recent occasion with a drawing-room company, where, among the amusements of the hour, a recital of imp verses evinced a good degree of familiarity with the poets and authors, and also excellent powers of mind in criticising the faults and commending the graces of past and present themes of conversation. Prom inent in this encounter of wits was a young lady, a teacher in a public school, where most of her pupils are white. Her literary essays at exhibitions and in the social circle have won for her the appellation of Poet Laurente. She was ably seconded by a young gentleman who has also been a public school teacher and who, while recently in London, desiring to travel on the continent, received a passport from the American minister to the Court of St. James, and thus, endorsed by the sign-manual of Hon. George M. Dallas, his sojourn in Paris was as an acknowledged citizen of the United States. Little did he then dream that on returning to 'his own, his native land,' he should find himself, by a worse than Draconian edict, pronounced an outlaw, having 'no rights that a white man is bound to respect.'

The colored people of Boston and vicinity have ac cess on equal terms to the public lecture rooms and libraries, and, indeed, to several of the churches; but while the majority do not refuse to fellowship those churches of their own denomination where their equality is denied, they (strange indeed as it seems) are influenced to refrain from attending those where their brotherhood is freely admitted. INDIAN TROUBLES AT THE WEST. BARRON HOUSE, FARIBAULT, Rice Co., Minnesota Ter., April 16, 1857.

There is much excitement here, and a great deal ore thirty-five miles west of this place, in consequence of some trouble with the Indians at Spirit Lake, and also at Springfield, a short distance from Mankato, which is situated on the Minnesota river. Most of the excitement, however, has been caused by false and exaggerated reports, to the effect that some eventy white settlers had been murdered; whereas no reliable information has been obtained here as yet that more than four or five have been killed. Last Tuesday night, the citizens of this place were called together to see what should be done. Exciting peeches were made by Gen-Shields and others, ompany of sixty men was formed for the protection of this place, and also to march to the source of trou ole, if need be, and six armed men were kept on duty all right for the protection of the town. On Wednes day morning, men were gathered from every direction some with guns and some without, to wait further or ders from Gen. Shields. Muskets, powder and balls were in the greatest demand. This excitement was kept up in a good degree through the day by the nore impulsive portion of the men, and the wome passed sleepless nights; while the more cool and con siderate amused themselves by ridiculing the whole

This (Thursday) noon, an Indian boy, sixteen year old, who was despatched from this place to St. Peter last Monday, for correct information, &c., returned and I repaired to the Faribault Hotel to hear the

news. The bar and sitting-rooms were filled at one when Gen. Shields mounted a chair, and read a long letter from a Mr. Hezlep, editor of a St. Peters jour nal. It appears that a party of forty armed men left Mankato on Saturday last, in pursuit of the Indians and on Sunday or Monday had a skirmish with som few Indians, killing six, only one of their own com pany being wounded. On Sunday, a company of fif ty armed men left St. Peters for the seat of trouble on Monday fifty more, and on Tuesday fifty mor The first company had been heard from, and they ex pected to have a fight the next day. The settlers al hrough that region of country had become very much alarmed, and men, women and children were leaving their homes, and flocking into St. Peters by hundreds The Indian boy that went to St. Peters was taken prisoner by the whites seven times during his tediou journey. Efforts are being made here to keep the quiet and peaceable Indians in their own localities much as possible, lest in this time of undue excitement among the whites, some of the various partie may be shot, and a general outbreak of the Indian follow. AN UP-HILL BUSINESS. The Colonization Herald for April publishes a table showing ' the number of emigrants sent to Liberia by the American Colonization Society and its auxiliaries in all the states from 1820 to 1856 inclusive. It appears that the total number sent out during this period of thirty of these, 3,676 were born free; 326 purchased their own liberty; and the remaining 5,500 were emancipated for emigration. 'Virginia sent out a larger number than any other state, no less than 3,315 having gone from within her borders.'

These statistics can give but small encouragement to those who look to this society for the final extinction of American slavery, especially when compared with the increase of slave population during the same period. In 1820, although slavery then existed in New York, New Jersey, Pennsylvania, Rhode Island, Illinois and Indiana, the slave population of the country, as shown by the census, was 1,538,038; and in 1850, long after slavery was abolished in all the states mentioned, it was 3,204,313, showing an increase in thirty years of 1,666,275; while the American Colonization Society, for thirty-six years, has liberated less than six thousand. That is, while the slave population has increased over fifty-five thousand a year, the Colonization Society has liberated less than six thousand. thousand a year, the Colonization Society has liberated two hundred and fifty slaves a year. How long it will take the Society, at this ratio, to abolish slavery, we leave those interested to figure up.—
