He has written a long letter to the N. Y. Daily Times, announcing his purpose shortly to come to the North and lecture. From his manifesto, we extract the following, which contains the gist of the manter. the gist of the matter :-

There, we feel easier now. Brownlow is coming ! We have had any quantity of sermons from Hallett, Loring, Dr. Adams, Dr. Lord, the N. Y. Observer, the Biston Post, and such able champions of slavery. We have been lectured and berated and labored with and now, last of all, Gov. Gardner has gone over to the union-saving, negro price-raising politicians, and tells us that it is very foolish to talk any more about freedom, that there are no national issues now remaining, that Kansas and all such matters are as a 'dead horse,'-but with singular obstinacy, the good, honest people of Massachusetts and of New England still seem to think that the issue between freedom and slavery is of importance. They will neither heed Hallett nor the Post, Rev. Dr. Adams nor Governor Gardner! It evidently requires the genius and the exertions of a Brownlow. We welcome the Parson, not as his southern brethren would welcome us with tar and feathers, a ride on a rail, or a rope and a short shrift on the nearest tree, but we will give Brownlow good large halls in which to speak, quiet and orderly audiences of New England citizens, and all the cheer he can desire while he tarries among us. If we may be allowed to suggest a few points which it will be well for his to try and make clear, we suggest the following:—'That negroes cannot take care of themselves,' illustrated by such examples as Rev. Dr. Pennington, Fred Douglass and Dr. Rock. That slave labor is more profitable and enriches the country faster than free labor, illustrated by the history of Virginia, North Carolina, Kentucky, Tennessee and Missouri, That slavery tends to humanize and christianize men and women, illustrated by Elder Netherland, the Tennessee deacon's whipping his slave and fellow church member murdered his master because he had brutally violated the slave's wife and daughter. By way of general illustration of the beauties of slavery and the awfulness of Northern diabolism, the Parson might contrast our free schools with the general prevailing Southern ignorance; our family relations, with the universal adultery and fornication practised on Southern plantations; and the quiet and order of the Sabbath in Boston, with the horse-racing, cockfighting and gambling which characterize the observance of the same day in New Orleans! These will do for the present as themes for Parson Brownlow when he gets along to New England. We hope he will not, however, neglect in his discourses to make good use of the late discovery made and proclaimed by Gov. Gardner, that all national issues are settled, and that we need not concern ourselves any more Excellency agree very readily, and we see not why they may not be mutually useful.—Boston Bee.

REPLY TO THE PRESIDENT.

From the New Haven Palladius To HIS EXCELLENCY JAMES BUCHANAN, President of the United States.

In July last, a number of citizens of Connecticu addressed to you, as Chief Magistrate of this nation, a memorial on the affairs of Kansas. To this you replied, under date of August 15, 1857, in a manne which shows that you misunderstood, to some ex-tent, the ground taken by the Memorialists, for we would not impute to you the intention to misrepresent them. As you have thought proper to lay the Memorial and reply before the public, a large part of the Memorialists have conferred on the sub ect, and have felt themselves compelled again to ad dress you. We would remark, then, that the main facts alleged in that Memorial are either passed over without dental, or are explicitly avowed in your reply

These facts are two: First, 'that the fund

nental principle of the Constitution of the United States and of our political institutions is, that the people shall make their own laws, and elect their own rulers.' Secondly, 'that Governor Walker of Kan-sas openly represents and proclaims that the President of the United States is employing through him (Walker) an army, one purpose of which is to force the people of Kansas to obey laws which are not their own, nor of the people of the United States; but laws which, it is notorious, and established upon evidence, they never made, and rulers they never elected.' As to these two facts, the material facts alleged by your Memorialists, and which chiefly require vindication from you, they say that they find no denial of them in your reply. They do not say that you have attempted no vindication of your ly, that they can find in your reply no plain or explicit denial of the facts referred to—not even what they consider the shadow of a denial.— These facts stand in the Memorial, then, uncontradicted, by what you evidently consider a triumphant reply. Why is this? Are these assertions, upon reply. Why is this? Are these assets, untrue which the whole subject at issue depends, untrue and yet no denial of them—not a word to prove them untrue? Without such denial, what can you expect your Memorialists and the country to believe and to say? What, but the facts, which they allege are notorious and undeniable?

As to the allegation respecting the fundamental

principle of the Constitution, your Memorialists hope that the time is remote when the enlightened citizens of this country will deny that principle; though party zeal, in its infatuation, may one day trample it in the dust, when, in light of the ruin, Liberty and Religion in exile will together weep over

Can such an outrage be clothed with authority by a President, Senate, Congress, or a whole Congress of Presidents? Can usurpation beget a valid government or law, or impart that right to govern which implies an obligation to obey? Its might may make it an act of prudence to avoid its wrath

by submission, but can usurpation create an obligation to obey when none exists?

Suppose the Great Mogul, or any other tyrant, had established the same so-called government and laws of Kansas by the same means by which, as all the world knows, they were establish vasion and arms—would any citizens of the United States call them 'government and laws,' except in States call them 'government and laws,' except in derision and loathing? Your Memorialists will now present what they consider the fundamental error of your reply. In their view, in recognizing the Territorial Government and laws of Kansas as a genuine government and valid laws, you have perverted the general principle on which you rest your vindication, and have violated its assential spirit and meaning.

you rest your vindication, ntial spirit and meaning. That general principle may be thus stated: When rules of action, claiming to be valid laws, proceed from a rightful law-making power, it is the duty of the people and the executors of law to recognize them as authoritative. To this, as a general principle, your Memorialists subscribe. It is the only means of giving practical authority to law, and of preventing violence and affarchy; nor do they yield means of giving practical authority to law, and of preventing violence and ariarchy; nor do they yield to any man or class of men a higher estimate of its importance, or a firmer determination to adopt and defend it, than themselves cherish. But to say that ALL governments and ALL laws, claiming to be valid, must be recognized, executed and obeyed as such, is as preposterous as to deny the general principle itself. To mistake the general rule for a universal rule, the conditional for an unconditional principle, must

lead to false reasoning and to practical conclusion of the most dangerous character. This, in the view of your Memorialists, who believe that none are too wise or good to err, is what you (they trust inad-

vertently) have done.

In recognizing the Territorial Government and laws as authoritative, have you not violated the whole spirit and meaning of the general principle laid down? Have you not wholly disregarded the essential condition, that the only government which it is your duty to sanction must present some cri-dence of rightful authority? You recognize the Territorial laws as valid. What is this but to act upon the principle that, when the so-called governow of evidence of their proceeding from a rightful law-making power, but with the most decisive and overwhelming proof that they have originated in a palpable and violent usurpation—that even then— even in a case so flagrant, it is your duty to sustain and execute them, even by the armies of the United

Your Memorialists are here anxious to call your attention to an important distinction, which you appear entirely to overlook. They readily concede that, in cases of no unfrequent occurrence, one government may frequently recognize another as au-thoritative, or as a government de facto, on a very low degree of evidence, without rigidly investigating low degree of evidence, without rigidly investigating its authority, or even considering its origin. For example, the government of Great Britain, when Louis Napoleon was enthroned in France by the army of the Empire, and with the acquiescence and consent of the people, had no right to interfere with a government thus 'established.' The British, as a foreign government, had no right of question or of control in the matter. ### SLAVERY AND COMPENSATION.

Messas. Editors:—You have justly characterized as impracticable and absurd the scheme devised by Elihu Burritt, and published to the world, at a convention recently held in Cleveland, Ohio, proposing that the slaves be bought, from those who assume to be their owners, by the proceeds of the sale of the public lands. There are several reasons why it is both impracticable and absurd; but the first of these, (as in the case of the man whose absence from a cer-(as in the case of the man whose absence from a cer-tain place was accounted for by six reasons, the first being that he was dead,) covers the ground so amply that we need not trouble ourselves to enumerate the others. Mr. Burritt has overlooked that chapter in the wisdom of ages which admonishes a man not to 'reckon without his host,' and reminds him not to 'reckon without his host,' and reminds him that 'it takes two to make a bargain.' Not only has he underrated both the number and the market value of the slaves, and thus exposed himself to the charge of wishing to cheat the slaveholders if they were disposed to enter upon a negotiation, but his plan is naught, as being a proposal to buy what the holder does not propose to sell, on any terms. Accordingly, and very naturally, the Southern newspapers receive this plan with unmitigated contempt and ridicule.

In saying that that proposition to pay for the slaves is an admission, on the part of the most ultra abolitionists, of the right of property in them, you, Messrs. Editors, seemed to have formed the erroneous supposition that the abolitionists were represented in this convention. \*It is true that many persons in the community have failed to mark the distinction between the Republicans, who are carrying on a movement, by political means, against the extension of slavery, and the Abolitionists, who are carrying on a movement, by moral means, against slavery itself. The former purpose to confine slavery to its present boundaries, expressly pledging themselves to offer no obstruction to its indefinite continuance there, if the slaveholders, on their part, will agree to the limitation. The latter, believing that the black man has as much right to liberty as the white—and that slavery is as bad for Kentucky as for Kansas—and that Massachusetts is as much dishonored by co-perating, through the Federal Government, to support slavery in Kentucky as in Kansas, refuse all compromise with a system so fundamentally unjust, labor for its utter and absolute overthrow, and propose to continue this system of effort while a sincle slave right in the payment of the country.

ly unjust, labor for its utter and absolute overthrow, and propose to continue this system of effort while a single slave exists in any part of the country.

Apart from Gerrit Smith, who is an exceptional person, a man, sui generis, and full of the strangest inconsistencies, which long ago separated him from co-operation with the measures of the abolitionists, I recollect no person whatever in Mr. Burritt's convention who can properly be represented as either being, or having been, in their ranks. It is probable that the members of that convention have acted, heretofore, and are still continuing to act, with the Republican party; it is highly probable that they would agree never to say another word against slavery, if it could be returned and retained within the limits of the Missouri compromise; but it is certain that they are not abolitionists.

Among other matters, deeply affecting the interests of the whole country, which are looked at by this Southern gentleman from the economic and practical point of view, and treated with great vigor and originality, is this very question of compensation to slaveholders. It is said that that infatuated journeyman printer had no money to start with—even slept in his printing-loft, and ate nowhere in particular. Even now, fame has it that he has no money to speak of, after twenty-five years' service in his forlorn enterprise. Well, he will have his labor for his pains, and continue to be, as he has been, well laughed at. Mr. Casby and his friends, with Mr. Pancks, their factotum, betake themselves to Cleveland, and settle the whole slavery question in three days. Long live the practical nen, we say! Down with your theorists, your sentimentalists, your visionaries! Money makes the mare go! Let us hasten to try it upon this obstinate jade of Reform, that has stood there kicking, and backing, and biting, till we and the world are out of pa-

We must be allowed to lay our thumb upon our nose, and wriggle our fingers at Garrison, however, he was so jolly green. We congratulate these excellent financiers upon the despatch with which they have achieved the negotiation. The slaveholders are to have \$250 per head for each slave from Congress, together with an enhancement of their real estate, reckoned at 100 to 500 per cent.: this, however, not to preclude the several States and private charity from eking out these trifles to something handsome. To be sure, the slaveholders were not there, either in person or by any authorized brokers. No doubt if Mr. Aiken, or Lower and the state of Lower Paris had been resent to Toombs, or Jefferson Davis, had been present to stick for \$300, they would have got it. They showed their good sense and faciliated the arrangement ossentially by staying at home. Now that the whole thing has been settled by men so closely in their confidence as Elihu Burritt, and Revs. John Rankin and C. W. Dennison, they would be most unreasonable to arrest the consummation by any im-

pertinent objections.

Of course, the settlement of the main question settles all the collateral questions. The President, Governor Walker and the Border Ruffins will no Alvan Howes longer subject themselves to the trouble of getting slaves into Kansas, since they are all inventoried and to be redeemed below the market rates. The D. R. Samson, slave-markets of Baltimore, Charleston and New Orleans will go down with a rush, and gangs that cost \$1,000 per head the week before the Convention, must go off heavy at \$250, and failures among drovers be the immediate consequence. The pater-nal estimation in which chivalrous Virginians hold their vellow children must abate in a manner mos discreditable to human nature. Only think what a dead loss of human virtue it would be to lose at a blow 75 per cent. of our fatherly affections! Our little boy says he loves us a hundred dollars, and of course estimates our reciprocated love at an equal figure. Ought not the National Compensation Emancipation Convention to hesitate before they de cide to cut down a Virginian father's affection for his likely mulatto son and promising quadroon daughters from \$750 to \$250? Do they make war

upon the holiest natural instincts?

Mr. Casby and his friends have wisely considered the wants of the emancipated also. 'The small sum of twenty-five dollars to each of these wronged and destitute ones would go far towards providing them with humble homes upon this continent, or upon another, should they prefer so wide a removal from the land of their birth.' This is not a magnificent provision of itself, but very liberal under the circumstances. Mr. Casbysteps into the parlor, Pancks sweating and tugging behind with the money-bags, and shakes hands with the assembled masters. The courtesies duly exchanged, he sits down to settle with them. Pancks counts out the \$1,000,000,000, which they receive with the high-born dignity which so becomes their chivalric descent, and civilly invite Mr. Casby to dinner, leaving Pancks to fix the papers. After a not too ceremonious meal, the great Casby retires, and at the foot of the avenue encounters Cuffee 'minding the horses,' and having an inkling of the late transaction. Of course, in so heavy a business, two and a half eagles is coin enough to throw into Cuffee's hat. Mr. Casby has always thrown five dollars where common men throw York shillings. In this case he can be excused, after having just disbursed \$1,000,000,000, if only a few hundred remain in his bag, and he and Pancks must travel home respectably. We are serious in maintaining, therefore, that \$25 is liberal. But we suggest that it be put on a little different ground -that it be considered as a fee for holding the horses, or to drink the two gentlemen's health, and not as going far towards setting up a naked, shoeless, shirtless, hatless African Lazarus as a land-holder, housekeeper and responsible head of a family. Why, it seems to us that if we had been in slavery, and our ancestry, ever since there was any tradition to us, and we were suddenly emancipated, that we should not think of investing less than \$25 in such hilarity as was proper for the occasion. We fear these merciful, joyous, rollicking negroes, coming suddenly in possession of \$25 a piece under such circumstances, would decide, nem. con., to devote the whole sum to drinking the healths of the gentlement of the National Compensation Emancination.

In Iowa, in submitting the new Constitution, the question of equality of whites and negroes, as to political privileges, was submitted to the people. Nearly the whole vote of the State was against the assumed equality. After all the pretences of Black Republicanism in favor of negro equality, nearly the whole party voted against it. Few men in Iowa were found voluntarily to vote themselves the equals of negroes. When brought to the test, their negro professions were found to be mere political expedients, which honest men despise. Look at the position of Parson Sawyer. He was a minister of a slaveholding church, and had heretofore been perfectly acceptable in that capacity. He had no objection to slavery, but being a weak and inconsistent man, he objected to cruelty, even when exercised in behalf of slavery. He wanted to adapt the reality of slavery to South-side Adams's fanciful and fabulous description of it. When, therefore, a deacon of his own church had subjected an aged negro, merely on suspicion, to such intolerable and long-continued torments, using a handsaw as the instrument of torture, that the neighbors and the owner of the building interfered for the relief of their own ears from his screams—and the sheriff and jailer afterwards interfered when the same discipline was menced in another place—Parson Sawyer assumed this discipline to be cruelty, and, feeling some official responsibility in the matter, he undertook to have this cruelty discountenanced by the slaveholding me of the church. To his surprise-we have said that he was a weak-minded man—the church discountenance him instead of Deacon Netherland, told him to mind his own business, and, by way of lielping him to do so, discharged him from his pastorate.

B. to be true\_though I have heard it questioned by a truetee, who said he had no knowledge of such an agreement, and there is nothing in the records which goe to show any agreement, -but, admitting H. W. B. statement to be true, we claim that the meeting, house is opened (oftener than) occasionally for reform atory evening meetings, both Anti-Slavery and Tenperance. I doubt if there is another meeting house in Massachusetts more frequently and freely used for such meetings than the one in this village. I put it to your correspondent himself, (and I am informed that he has contributed quite liberally in the erection of three or four other meeting-houses in this town. with the same expectation that he says he had when he contributed to the erection of the one in this village,)-I put it to him, if the meeting-house here is not more frequently and freely opened for Anti-Siavery or Temperance meetings than any or all the others in this town.

Again, it is said, \* Last year, application was made for the house one evening for a lecture on Anti-Slavery, to be delivered by the editor of THE LIBERA-TOR. It was at once refused by the minister, on account of the religious views of the lecturer.' True, every word of it; and let me add, so far as I am concerned, I should do it again for the same ressua. Then follows a statement that the 'Abelitionists were informed by the President of the Board, that the trustees had voted to let them have the house four times a year for Anti-Slavery meetings, and that Mr. Garrison would be admitted to the meeting-house." In your comments on the above you say, 'To obtain more money of the Abolitionists in that place, a vote is passed granting us the use of the house uncondi tionally.' My reply to the statement of H. W. B., and also to yours, is simply this: they are not true, The matter never came before the trustees at all, until a member of the . Committee to whom applications for the house shall be made, reported that they had let the house to Messrs. Blanchard and Bartlett for antislavery meetings. But perhaps it may be said that the 'Committee to whom applications for the use of the house shall b made ' voted to let the house to Messra, Blanchard and Bartlett for Mr. Garrison to occupy, &c. My reply to this is \_lst, that is not the statement of H. W. B. and, 2d, I doubt whether the Committee ever had a meeting to act upon the subject. At all events, the writer is a member of that Committee, and has no knowledge of any such meeting. Certain I am, that I never was notified of any such meeting of the Com

But before I dismiss this subject, I wish to refer to the matter of a 'tax laid on the pews to pay for gas fixtures and repairs,' to which H. W. B. refers in his communication. Mr. Editor, justice and truth require me to say, that this 'tax' was not 'laid on the pews by the Methodist brethren of Port Norfolk, but by the 'pew owners,' in a public meeting called for that purpose: and although I have not the records by me, yet I will venture to say, there were more votes cast for this tax by those not Methodists, than by those

THE DISSOLUTION OF THE UNION.

Having published my letter to Mr. Howland, MR. GARRISON: you let me, through THE LIBERATOR, address a few essays to your readers on questions preliminary to a dissolution of the Union, should either the free or slave States resort to that remedy?

By THE LIBERATOR it appears that some of your correspondents admit that if the free States should secede from the Union, it would be a revolutionary movement. This, in my humble opinion, is an erra, which, under the discussion of this vital question necessarily renders it more unpopular than it offer wise would be. This question rests upon the arter of our peculiar system of government. Jefferson and Madison in these Reolutions be true, then secession would be neither refolution nor rebellion, let the result be what it might These Resolutions unquestionably assert, what the Proclamation denies, the absolute sovereignty of each State in the Confederation; and Massachusetts codorses this assertion by asserting her sovereignly and requiring an oath of allegiance to the sovereign pos-

If secession would be revolution or rebellion, then er of the State. it must be conceded that the 'rebels' would be 'mitors.' The fear of being called rebels and traiter is the best possible check to free inquiry. Hence the

Now, 'treason' is expressly defined in the Federal Constitution to 'consist only in levying war against

the United States, or in adhering to their enemies, riging them sid and comfort. There is, then, no crime as 'constructive treason.' 'Treason Webster defined to be a violation of allegiance." Now, if the free States, planting themselves on their correignty, and commanding the allegiance of their etive citizens, should secrete from the Union exceptly, it could not possibly be 'treason,' accordto the constitutional definition of that term, or acerding to Mr. Webster's definition; neither would a be rebellion, because it would not be an open reanciation of allegiance' to any authority, but an aboute rendition of allegiance by the citizens of each weding State to the sovereign power of their respecstates, to whom only their allegiance can be due. General Jackson's Proclamation assumes that the argiance of the citizens of each State is due to the gral Government, because they ' owe allegiance to ass' enacted by Congress. This is sheer sophistry, the resort of those who have no reasons to advance. his true, however, that the citizens of each State to at obedience to all laws enacted by Congress, passpl in pursuance of the Federal Constitution, not, as the Proclamation falsely asserts, because their \* allepance was transferred, in the first instance, to the gorament of the United States,' but because their setive States, to whom their allegiance is due, repetive States, to whom their allegiance is due, command, through the sovereign power of the State, the obdience to laws passed by the Federal branch of their State government.

'Treason,' says the Proclamation, 'is an offence minst sovereignty, and sovereignty must reside with the power to punish it. This assertion, taken in conaction with the previous denial of the sovereignty of the States, and the assertion that the 'allegiance of their citizens was transferred, in the first instance, to the covernment of the United States,' is an unequivged, though indirect, assertion that sovereignty resides in the Federal Government; while it also unwittingly concedes that each State is sovereign, becase each has the right to 'punish treason,' as acknowledged in the Federal Constitution, Art. iv., This prevarieating theory makes two sovereignties

to whom the allegiance of the same citizens must be dae. Such an absurdity needs no comment. Now, if there is such a thing as political sovereign-

re, it cannot reside with the mere servants of the people, the source of all power, but it must reside with the people themselves, with whom sovereignty is inent. With what people? This is the important question. Let the State Constitutions, as the Federal Constitution is silent on this question, answer. They all claim that the people of each State form a sovereign community, to which the allegiance of the citizen is due. The opponents of this theory have no settled penciples. Sometimes sovereignty is divided-sometime it resides in one place, then in another-some times allegiance is due to government, then it is due to sovereignty. Let the Proclamation be consulted in proof of this diversity of opinion, or rather no opinion

Let me here urge your readers to examine carefully the sunexed description of our system of government by Mr. Jefferson, written near the close of his useful

The States in North America which confederated to establish their independence, of which Virginia was one, became, on that acquisition, free and indewas one, became, on that acquisition, free and inde-pendent States, and, as such, authorised to establish governments, each for itself, in such form as they thought best. They entered into a compact, which is called the Constitution of the United States, by which they agreed to unite in a single government, as to their relations with each other and with foreign nations, and as to certain other articles particularly spetified. They retained, at the same time, each to it-telf, the other rights of independent government, comhending, mainly, their domestic interests.
For the administration of their Federal branch.

they agreed to appoint, in conjunction, a distinct set of functionaries, legislative, executive and judicial, in the manner settled in that compact; while to each severally, and of course, remained its original right of appointing, each for litself, a separate set of functionaries, legislative, executive and judicial, also, for administering the domestic branch of their respective governments. These two sets of officers, each indedent of the others, constitute thus a whole governpendent of the others, constitute y; the powers ascribed to the one specifically made Federal, exercised over the whole; the residuary powers, retained to the others. er, exerciseable exclusively over its particular State, foreign herein, each to the other, as they were before the original compact.'

The above is the best and most graphic description of our complex, yet simple, form of government on regord. It proves the absurdity of calling the \* Federal branch' of our State Governments the ' National Government.

But we all, with one accord, testify to the truth of the anti-slavery principles, and entreat the aid of all whom this appeal reaches, to deliver the country from such a despotism, by their promulgation.

A School Teacher Cut to Pieces in Texas.—A terrible affair took place about eight miles east of Greenville, Hunt co., Texas, on the 3d of July, between a school teacher by the name of Moore, and a man by the name of Jesse Howard and his four sons. Moore undertook to chastise Howard's son, about twelve years old, for writing indecent language in a young lady's copy-book. He had struck the boy but four or five blows with a switch, when the boy's brothers came into the school-house with clubs, and one of them struck the teacher with a heavy club on the forehead, and felled him to the floor. The other struck the teacher several times while down, but he recovered himself, and got out his pocket knife, and drove them out of the house.

But, at this juncture, the old man, two other sons, and two sons-in-law arrived, and the old man rushed into the house with a large dirk pocket-knife. Moore begged Howard to spare his life, telling him he was then nearly dead. At this time, Moore lad a severe contusion on the forehead, and was covered with blood. But Howard, disregarding his entreaties, rushed upon him, and plunged his long knife into him on the right side, both of which wounds entered the cavity. Moore broke from him. bounds entered the cavity. Moore broke from him, when Howard cut him on the right shoulder, making a frightful gash four inches long, and to the bone. With all his wounds, Moore broke from the house, and ran twenty rods. The boys outside threw clubs at him as he ran, one or two of which

hit him.

Moore was a young man, of slight make, and in poor health, who had lately come to this State. He was a man of unexceptionable character, and a successful teacher. He will probably die of his wounds, a victim of revenge so low and despicable that humanity blushes at the recital. The antecedents of Howard and his family are in keeping with this act, they having been frequently engaged in brutal assaults upon their neighbors; and the family are reported to be guilty of every mean act. ly are reported to be guilty of every mean act.
Moore had had a difficulty with the same child before, and had requested Howard to take him out of the school. The old woman replied she meant to send the boy to devil him, and that if Moore whipped the boy, she would make Howard cut his determined to the control of the

It is generally supposed that the boy was urged to provoke Moore to chastise him, and no doubt they expected it that morning, for they all arrived at the school-house in a few moments after Moore commenced to whip the boy, and the two eldest brothers were secreted close to the house, for they got to the door before Moore had struck the boy six blows. The Howards lived a half a mile from the schoolhouse. Such are some of the facts of this horrible affair, as appears from the evidence on examination.

The old man's bail bond was fixed at \$4,000; the oldest sons at \$2,000, and the other three sons at \$250 each. But they have not yet, and probably cannot give bail. The public feeling is against them, which induces me to hope that they will get their deserts.—Cor. Chicago Daily Press.

Horrid Murder.—A most horrid murder was committed near Madison, in this county, on Wednesday morning last, upon the person of Mrs. Davis, wife of Mr. John Davis, by a negro man belonging to the latter, during his absence at St. Louis. His strange conduct caused Mrs. Davis's daughter to go in the direction of the well to see after her mother. in the direction of the well to see after her mother, when, before going far, she saw her lying by the well, and on approaching, found her bleeding pro-fusely, and dead. She raised the alarm, and neighbors were summoned to the spot, who, on examina-tion, found Mrs. Davis's death to have been caused by a deep wound with an axe in the neck, nearly

man by the name of George Matheny, alias Tucker, who resided at Bonne Femme Township, in this county, was arrested on suspicion of horse stealing, and placed in the county jail at Fayette. He came to this county last February, we believe, and had formerly lived in Johnson county, where he was also suspected of horse stealing, and where he killed one of a party who were trying to force his door for the purpose of lynching him.

His neighbors had him under surveillance for some time before his arrest, and were convinced that he was connected with a band of horse thieves. After discussing the matter for some time, and collecting all the facts they could in reference to him, last Saturday was fixed upon for his confession and execution. There were some three or four hundred people in Fayette that day, drawn there by the news of what was to take place. The company which had the business in hand, numbered some fifty or sixty persons, though they must have had the silent sympathy and encouragement of a portion of others in the place. This company stopped at the edge of the pathy and encouragement of a portion of others in the place. This company stopped at the edge of the town, and sent in a messenger to learn the state of the public sentiment. A vote was taken of the crowd present, and one hundred and twenty were against the mob proceeding, and ten for it—a large number refusing to vote.

After this vote was taken, the mob marched directly to the jail, and commenced forcing open the doors. Two or three gentlemen appealed to them to desist, and let the law have its course with the to desist, and let the law have its course with the culprit, and not bring such a disgrace and stigma upon our country as the carrying out of their plans would irretrievably fix upon us. Their appeals were in vain. Meantime, the culprit hearing the noise and confusion outside, and truly interpreting what was the object, took his handkerchief, and fixing one end about his neck, and tying the other to the flooring above, sought to put an end to his existence. The handkerchief broke, however. He then took a strong linen towel, tore it in two, and succeeded in hanging himself before an entrance was effected. These facts were learned from a negro man who was in the jail.

Upon hearing that the prisoner had taken his life, and upon being convinced of the fact, the mob quietly dispersed. The man was taken down in the evening, and an inquest was held on his body, and a verdict in accordance with the facts rendered.— Glasgow Times.

Terrible Tragedy at Goldsboro'.—We learned yesterday the following particulars of one of the most dreadful tragedies we have ever been called upon to record. From the information before us it appears that Dr. Davis, a highly esteemed physician of Goldsboro', in this State, bought a few things from a German Jew pedlar, who resides in the same place. The Doctor offered to settle for the articles at the The Doctor offered to settle for the articles at the time he purchased them, but the pedlar being busy at the time, told him that he would prefer that he, would pay the bill at some other time. Upon this the Doctor thought no more of the matter, and having occasion to go out of town, perhaps the next day, on business, the German Jew in the meantime gave his bill to an officer for collection. The officer called at the house of the Doctor in his absence. When Dr. D. returned, he took occasion to denounce both the officer and the Jew in pretty round terms for their conduct. The case was brought before a mag-istrate of Goldsboro' on Thursday evening last, when the Doctor charged the German Jew with swearing falsely in regard to the amount of the bill The pedlar retorted that the Doctor himself had The pedlar retorted that the Doctor himself had sworn to a lie; whereupon Dr. Davis struck the pedlar, and the latter drew a five shooter, and fired a ball through the Doctor's body. The Doctor then attempted to seize the German Jew, when he fired another shot at the Doctor, but the latter striking the pedlar's arm at the moment, the ball took effect in the body of his (the pedlar's) son. The pedlar then approached the Doctor, and placing the muzzle then approached the Doctor, and placing the muzzle of the pistol at the forehead of Dr. Davis, was in the act of firing the third shot, when the Doctor's son gave him (the pedlar) a blow with a shovel which split his head wide open. It was reported here yesterday morning that Dr. Davis, the German Jew and his son, all three died through Thursday night.—Raleigh (N. C.) Register.

The Wholesale Poisoning Case in Alabama.— We published an item by telegraph a few days ago, announcing that thirty-seven persons had been poi-soned by a German or Hungarian named Comiska, in Pike county, Alabama. A meeting of our citizens was immediately called, and prompt measures taken to send out numerous parties to aid in the efforts being made to arrest him, and to guard all the points in or near the town that he would be likely to pass in his course, should he come this way. As soon as the sentence of death had been agreed upon, one of the Court arose, and stated that as injury to the jail and danger to the prisoner were to be apprehended from the populace, the sheriff ought to proclaim publicly that the court had ordered the woman to be hung. From the character of the symptoms of the afflic From the character of the symptoms of the afflic-ted, suspleions of poisoning were aroused, which were subsequently fully corroborated by investiga-tion. On the premises of the cook, which were also occupied by two other servants, were found parcels of lump and carbonate of lead, with a vial contain-ing sugar of lead. These and similar deadly poisons, as every attendant circumstance warran had been introduced from time to time into the food had been introduced from time to time into the lood and drink served to the family, causing a slow process of death. On yesterday (Monday) evening, Ella, the youngest surviving daughter, died under the loathsome affliction. The Chesterfield authorities were immediately consulted, all the circumstances fully stated, and the arrest authorised. The rest of the family are slowly improving.—Richmond Description.

A Bloody Tragedy in Texas.—We find the fol-lowing in the Dallas Herald of the 29th ult :— 'It becomes our duty to record one of the most desperate and heart-rending tragedies that have ever been enacted in this region of the country. John Robinson, living some four or five miles from Birdville, Tarrant county, on Friday morning of last week, without previous provocation, as we are in-formed, almost without an intimation of his fiendformed, almost without an intimation of his fiendish intentions, shot and killed two brothers, George
and James Anderson, brothers of his wife, then attempted the life of his wife, and, failing in that,
proceeded deliberately to his neighbors', old man
Sublet, a distance of nearly two miles, and, while
the old man was pleading for mercy, shot him dead.
Returning to within a short distance of his house,
Robinson finished this horrid and unnatural tragedy by placing the muzzle of his gun against his own forehead, and pushing the trigger with the ram-rod, put an end to his own life instantly. The whole affair occurred in less than an hour.

Robinson previously had a difficulty with his wife, and had agreed to a separation. Her brothers were assisting to remove her things, when he shot them both with a rifle and a musket. Some time ago, Robinson committed a brutal assault upon old man Sublet, and was punished with several months' imprisonment, which was probably the cause of his animosity against that individual.

Mystery, Murder, Romance and Crime in Mem phis, Tenn.—A short time since, a young man by the name of Tanner, in Memphis, Tenn., of most blameless life and manners, was assassinated in the street, at night. It was not known that he had an enemy in the world, and no motive of plunder could have prompted the deed. Here a desperate hand-to-hand fight took place, the mother unable to use the gun, lest she shot her girls, one of whom was badly cut with a knife. Finding the women too many for him, he fled. The citizens were in pursuit of him.

'Rumors constantly reach us from the upper country that the Vigilance Committee are raking the country fore and aft, and swinging every horse-thief and murderer they can find. A gentleman who came down the road a few days since states that he saw a dozen bodies suspended from one tree, and on another five. A great many of the desperadoes have passed through this town on their way to New Orleans, not considering it healthy for them to re-main any longer.'

Fool Shooting.—The New Orleans Delta of the 14th says—' A hostile meeting took place yesterday at the "Oaks," between Mr. J. W. McDonald, employer and choked him. The affair was witnessed by the deceased's wife and children.
