And whereas, the Council is informed that a citizen of Wheeling, in reclaiming a figitive from his service, has recently, at the city of Cleveland, Ohio, and on his return from that place to Wheeling, through the State of Ohio, received prompt and efficient aid, according to the Constitution and laws, and to the duty of comity between citizens of different States of the Union; and especially that Matthew Johnson, Marshal of the United States for the Northern District of Ohio, and W. C. Cleland, a conductor on the Cleveland and Pittsburgh Railroad, exerted themselves with intelligence, vigilance and courage, to baffle the operations of all opponents, and to secure the return of said fugitive to Virginia,—be it therefore.

Resolved, by the Council, That the thanks of the city of Wheeling are hereby tendered to the said Maithew Johnson and W. C. Cleland, and to all other, citizens of Ohio who have, in like manner, given proof of their good will towards this State, and their fidelity to the Constitution which binds the States together.

INHERENT SINFULNESS OF SLAVERY.
